**Sub: Violation of the AJ&K Public Procurement Rules 2017, Executive Engineer,  
Maintenance Division, Muzaffarabad's Tender Notice of Works for Different Govt. Offices.**

This is with reference Maintenance Division, Muzaffarabad's Tender Notice, published in daily "The News" on 13<sup>th</sup> Dec, 2018. It is observed that the advertisement is in violation of the AJK PPRA Rules 2017.

As per advertisement, "Maintenance Division, Muzaffarabad's reserves the right to accept or reject any quotation (s) without assigning any reason", which is violation of AJK PPRA Rules 2017, Rule 33 (1). Stated as under;

*33. Rejection of Bids.-(1) The Procuring Agency may reject all Bids or proposals at any time prior to the acceptance of a Bid or proposal. The Procuring Agency shall upon request communicate to any Supplier or Contractor who submitted a Bid or proposal, the grounds for its rejection of all Bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
