Sub: Violation of the AJ&K Public Procurement Rules 2017, The Principal, Azad Jammu & Kashmir Medical College, Muzaffarabad's Tender Notice for Supply of Air –Conditioned Bus.

Dear Sir,

This is with reference Azad Jammu & Kashmir Medical College, Muzaffarabad's Tender Notice, published in daily "The News" on 21st Aug, 2018. It is observed, the advertisement is in violation of the AJK PPRA Rules 2017.

1. As per advertisement, "the Committee reserves the right to accept or reject any or all quotation without assigning any reason", which is violation of AJK PPRA Rules 2017, Rule 33 (1). Stated as under;

33. Rejection of Bids.-(1) The Procuring Agency may reject all Bids or proposals at any time prior to the acceptance of a Bid or proposal. The Procuring Agency shall upon request communicate to any Supplier or Contractor who submitted a Bid or proposal, the grounds for its rejection of all Bids or proposals, but is not required to justify those grounds.

2. Also, Quantity can be increased or decreased by the authority. Any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to AJK PPRA Rules 2017, Rule No. 42 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under:

42. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works, namely:-

(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement:

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Bidders can quote multiple brands and models separately but not forget to furnish color brochures and complete technical specs of each quoted model in the quotation.
- General Sales Tax Number and National Tax Number of Suppliers/Firms have to be furnished with the bids.
- 02% earnest money of the quoted bid value in the shape of call deposit/ pay order/ security deposit in favor of the Principal Azad Jammu & Kashmir Medical College Muzaffarabad must be attached with the quotation failure to which shall result in rejection of the bid or quotation.
- Complete color brochures and technical specs of the quoted models and brands shall be furnished with the quotation.
- Pre-delivery inspection will be carried out at Islamabad/Karachi before delivery to the department.
- Quoted priced of the vehicles should include all enforced taxes that includes income tax, sales tax, education cess on the income tax @ 5 % Stamp Duty @ 0.25% TQT Rs. 2/per thousand will be deducted.
- All bids should include separate details of ex-factory rate, transportation charges and taxes mentioned in condition No. 8.
- Rates shall remain firm up to the delivery of the vehicle.
- No advance payment shall be made to successful bidder and payment shall be made after pre-delivery and post delivery inspection reports by the inspection committee.
