Sub: Violation of Balochistan Public Procurement Rules 2014, Mayor, Metropolitan Corporation Quetta, Quetta's Pre-qualification Notice for Civil, Electric and Plumbing Works.

This is with reference to Metropolitan Corporation Quetta, Quetta's Pre-qualification Notice published in daily "Jang" on 29th December, 2018. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, the Pre-qualification fee under is charged as PRs 10,000/- (Non-refundable), which appears costly in light of the BPPRA Rules 2014, Rule No. 26(2). Stated as under;

26. Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.
