Sub: Violation of Baluchistan Public Procurement Rules 2014, Senior Purchase Officer, SSP Administration for Dy, Inspector General Police, Quetta's Tender Notice for Purchase of RFID Based Laser Engraving Printer.

Dear Sir,

This is with reference to DIG Police, Quetta's Tender Notice published in daily "Dawn" on 4th May, 2018. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, 15 days of response time is not given and the date for submission/ opening of tenders is on 14-05-2018, which is 4 days short. It is violation of BPPRA Rules 2014, Rule No. 16 (1). Stated as under:

16. Response Time. — (1) The Procuring Agency shall give due consideration to the scope, magnitude and nature of procurement, while deciding the response time which shall not be less than fifteen (15) calendar days from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, as the case may be, in case of National Competitive Bidding, and shall not be less than forty five days (45) from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, in case of International Competitive Bidding.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Bids to be addressed to the chief Procurement Officer, DIGP Quetta and shall be received till 14-05-2018 before 11.30 am and shall be opened at 12:30 pm on the same day in the presence of bidders in DIG Police office Zarghoon Road, Quetta. The delivery period would be 30-days. Name of Item: RFID based Laser Engraving Printer

The bids shall be received under Single stage two envelop procedure as per Balochistan Public Procurement Rules 2014, the bids shall comprise a single package containing two separate envelopes. Each envelope shall contain separately sealed "Financial Proposal" and separately sealed "Technical Proposal". The envelope color of financial proposal should be "Khaki" and Technical proposal should be "White", containing the following documents/information noted against each:-

Technical Proposal: bidding documents, complete specifications of respective offered items on the firm's letter head pad alongwith catalogues, authorization certificates from the manufacturer, Sales Tax and Income Tax certificates etc) and documents required as per the Tender Document.

Financial proposal (Rate of respective item including all taxes, charges whatsoever as per following format on the firm's letter head pad):-

The envelopes should be marked in bold and legible letters as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" respectively with name of item and firm.

Technical proposal will be opened on **14-05-2018** at 12:30 pm while the Financial Proposal shall remain (in sealed form) in the custody of the Police Department and would be opened after receipt of technical evaluation report, in the presence of qualified bidders.

The financial proposals of bids found technically un-acceptable shall be returned un-opened to the respective bidders under the rules.

Rate quoted would be considered only if any the same are in Pak Rupees and inclusive of all taxes/duties/charges and inclusive of packing/ freight till delivery DIGP Quetta stores and shall be valid up to 90-days from the date of opening the financial bid proposal.

The bidders shall submit bid security 3% of the total bid value with their technical proposals in shape of Pay Order or Bank Draft of any scheduled bank in favor of the DIGP Quetta Govt of the Balochistan. Proposals without bid security with technical proposals will be rejected. In case of non-acceptance of bids, the bid security will be refunded after finalization of the tenders.

Police Department will not be responsible for any cost or expenses incurred by bidders in connection with preparation and delivery of bids subsequent presentations/demonstration of their samples.

The interested firms are informed to collect the bidding documents containing terms & conditions, standard specifications etc, from the office of the Procurement Officer (SSP Admin) DIGP Zarghoon Road Quetta on any working day during office hours, a day before the bids opening date. The bidding documents can be obtained up to 14-05-2018, on any working day during office hours at the cost of Rs.1,000/- deposited in Govt Treasury under Head 1232-Police receipt- Others in the NBP/State Bank of Pakistan, and may also be downloaded from BEPRA Official website.
