Sub: Violation of Balochistan Public Procurement Rules 2014, Chairman, Municipal
Committee, Sarnan's Tender Notice for Construction & Repair Works.

This is with reference to Municipal Committee, Sarnan's Tender Notice published in daily "Dawn" on 3rd Nov, 2018. It is observed that advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, "The Tendering Authority will reserve the right to accept/ reject any one or all tender rates without providing any reasons." It is violation of BPPRA Rules 2014, Rule No. 40. Stated as under;

40. Announcement of evaluation reports.— (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- The contractor/firm shall submit a call deposit from a scheduled bank in the name of tendering authority @ of 2% of the total cost.
- No advance payment shall be made to the contractor.
- All Government taxes shall be paid by the contractor.
- The rates offered should be clear, ambiguous and over-written rates will not be considered.
- The tender rates received after due date and time will not be accepted.
