This is with reference to Lasbela Irrigation Division, Uthal's Tender Notice published in daily "Dawn" on 8<sup>th</sup> Dec, 2018. It is observed that advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, "Lasbela Irrigation Division, Uthal reserved the right to accept or reject any one or all tenders without assigning any reasons." It is violation of BPPRA Rules 2014, Rule No. 40. Stated as under;

*40. Announcement of evaluation reports.— (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
