**Sub: Violation of Balochistan Public Procurement Rules 2014, Deputy Director
Procurement, Lasbela University of Agriculture, Water and Marine Sciences, Uthal's Tender
Notice for Supply and Arrangement of items for 2nd Convocation.**

Dear Sir,

This is with reference to Lasbela University of Agriculture, Water and Marine Sciences, Uthal's Tender Notice published in daily "Jang" on 10th January, 2017. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

1. In the advertisement, the last date for closing of tender is 26-01-17, whereas the opening is kept on 27-01-17. It is violation of BPPRA Rules 2014, Rule No. 33 (1). Stated as under;

33. Opening of Bids. — (1) *The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender.*

2. Also, "The Competent Authority reserves the right to reduce or increase the scope of work" whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to BPPRA 2014, Rule No. 51 (f) (i), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

51. Alternate Methods of Procurements.— (1) *A Procuring Agency may utilize following alternative methods of procurement of goods, services and works, namely:—*

(f) Repeat Orders.— *means procurement of additional quantities of the item(s) from the original contractor or supplier, where, after the items originally envisaged for the project or scheme have been procured through open competitive bidding, and such additional quantities of the same item(s) of goods or works are needed to meet the requirements of the project or scheme:*

Provided that—(i) the cost of additional quantities of item(s) shall not exceed fifteen percent (15%) of the original contract amount;

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
