**Sub: Violation of Balochistan Public Procurement Rules 2014, Executive Engineer-II, Provincial B&R, District Sohbatpur's Tender Notices for Construction Works.**

Dear Sir,

This is with reference to Provincial B&R, District Sohbatpur's Tender Notice published in daily "Jang" on 9<sup>th</sup> May, 2017. It is observed that advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, the Tender form fee for S. R. No. 1 & 2 is given as PRs 12,000/- and PRs 10,000/-, which appears costly in light of the BPPRA Rules 2014, Rule No. 26(2). Stated as under;

***26. Provision of Bidding Documents.** — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
