This office prints and supplies the textbooks from class Kachi to 10th in the Director of Education (Schools) on his written demand for free distribution throughout the Balochistan Province and on the written demand, the Director of Education (Schools) clearly mentioned that the quantity of free textbooks can be increased or decreased at the time of printing of 35% textbooks for Summer Zone Areas on need basis. As such this office will purchase up to 2,500 M.Ton printing paper keeping in the view the revised demand of Director of Education (Schools) regarding the textbooks.

From the above mentioned facts & figures and no objection has been received from Balochistan Public Procurement Regulatory Authority regarding the publication of corrigendum, the said issue may be treated as per provision of BPPRA Rules.
