This is with reference to Quetta Development Authority, Quetta's Tender Notice published in daily "Jang" on 10<sup>th</sup> June, 2016. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

As per the advertisement, no information regarding issuance of tender documents is given for bidders, which is violation of Baluchistan Public Procurement Rules 2014, Rule No. 26 (1). The Rule is quoted below for your reference;

***26. Provision of Bidding Documents. — (1) The Procuring Agency shall provide the bidding documents to all interested bidders in accordance with the procedures and requirements specified in the Notice Inviting Tender.***

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
