Sub: Violation of Balochistan Public Procurement Rules 2014, Managing Director, LIEDA,  
Quetta's Pre-Qualification Notice of Consultants for Various Works.

This is with reference to LIEDA, Quetta's Pre-Qualification Notice published in daily "Jang" on 12<sup>th</sup> March, 2019. It is observed that advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, "the Competent Authority reserves the right to accept or reject any or all proposals without assigning any reason." It is violation of BPPRA Rules 2014, Rule No. 40. Stated as under;

*40. Announcement of evaluation reports.— (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.
