Sub: Violation of Balochistan Public Procurement Rules 2014, Registrar, Balochistan University of Engineering and Technology, Balochistan's EOI Notice of Translation from English to Urdu of the University Acts, Statutes, Rules & Regulations.

Dear Sir,

This is with reference to BUET, Khuzdar, Balochistan's EOI Notice, published in daily "Jang" on 9<sup>th</sup> October, 2015. It is observed that the advertisement is in violation of the BPPRA 2014.

1. As per the advertisement, it is stated that "The University reserves all the rights to reject any or all the EOIs without assigning reasons". It is violation of BPPRA Rules 2014, Rule No. 40. Stated as under;

**40. Announcement of evaluation reports.**— (1) *Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.*

*Provided that a copy of the evaluation report shall be provided to any bidder who may request for the same.*

2. Also, "no EOI documents are issued, that shall include criteria for short listing", which is mandatory requirement of BPPRA Rules 2014, Rule No. 70. Stated as under;

**70. Request for Expression of Interest:-** (1) *Request for Expression of Interest shall be advertised or announced in accordance with the provisions of rule 15 and 16 above.*

(2) *Request for Expression of Interest shall contain the following information:-*

(a) *Name and address of Procuring Agency;*

(b) *appropriate description of the assignment providing scope of the intellectual and professional services required;*

(c) *deadline and place of the submission of Request for Expression of Interests;*

(d) **criteria for short listing;** and

(e) *any other information that the Procuring Agency may deem appropriate to disseminate at this stage.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the EOI under the prescribed procedures, or issue a corrigendum and extend date accordingly.
