Sub: Violation of Balochistan Public Procurement Rules 2014, Chairman, Balochistan
Development Authority, Quetta's Tender Notice for Construction Works.

This is with reference to Balochistan Development Authority, Quetta's Tender Notice published in daily "Dawn" on 8th Oct, 2019. It is observed that advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, the tender fee for S. No 2 is charged as PRs 20,000/-, which appears costly in light of the BPPRA Rules 2014, Rule No. 26(2). Stated as under;

26. Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
