Sub: Violation of Balochistan Public Procurement Rules 2014, AIG/ General for Inspector General of Police, Police Department, Quetta's Tender Notice for Purchase of Miscellaneous Items.

Dear Sir,

This is with reference to Police Department, Quetta's Tender Notice published in daily "Dawn" on 13th January, 2016. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per advertisement, "the department reserves the right to vary/alter the quantity as per requirement" whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to BPPRA 2014, Rule No. 51 (f) (i), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

51. Alternate Methods of Procurements.— (1) A Procuring Agency may utilize following alternative methods of procurement of goods, services and works, namely:—

(f) Repeat Orders.— means procurement of additional quantities of the item(s) from the original contractor or supplier, where, after the items originally envisaged for the project or scheme have been procured through open competitive bidding, and such additional quantities of the same item(s) of goods or works are needed to meet the requirements of the project or scheme:


Provided that—

(i) the cost of additional quantities of item(s) shall not exceed fifteen percent (15%) of the original contract amount;

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

2. The bids shall be received under "Single Stage - Two Envelope" procedure, as per Balochistan Public Procurement Rules 2014. The bids shall comprise a single package containing two separate envelopes. Each envelope shall contain separately sealed "Financial Proposal" and separately sealed "Technical Proposal". The envelope color of Financial proposal should be White, while the Technical Proposal should be White, containing the following documents / information notes against each-

- 1). TECHNICAL PROPOSAL** Bidding documents, without that 03% bid security in original is attached with financial bid. Complete specifications of respective offered items on the firm's letterhead along with catalogues, authorization certificates from the manufacturers, Sales Tax and Income Tax certificates etc.
- 2). FINANCIAL PROPOSAL** Bid security @ 03% of the value of bid. (Rate of respective item including all taxes / charges whatsoever, as per following format on the firm's letterhead:

 The envelope should be marked in bold and legible letters as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" respectively with name of item and firm.

3. Technical proposal will be opened on 28-01-2016 at 12:00 noon while the Financial Proposal shall remain (in sealed form) in the custody of the Police Department and would be opened after receipt of the technical evaluation report publicly. The financial proposals of bids found technically un-acceptable shall be returned unopened to the respective bidders under the rules.

4. Rate quoted would be considered only if the same are in Pak Rupees and not in any other currencies and inclusive of packing/weight/delivery CPC charges and shall be valid up to 30.06.2016 from the date of opening the financial bid proposal.

5. The bidders shall submit bid security 03% of the total bid value with their financial proposals only in shape of Pay Order or Bank Draft or any scheduled bank in favor of the Inspector General of Police Govt. of the Balochistan. Proposals without bid security will be returned as per BPPRA Rules.

6. Police Department will not be responsible for any cost or expenses incurred by bidders in connection with the preparation and delivery of bids subsequent presentation/acceptance of their samples.

7. The Chief Procurement Officer reserves the right to cancel bidding process as per Rules 56 of BPPRA.

8. The interested firms are invited to attend the opening, discuss regarding terms & conditions, contact specifications of respective items etc. from the office of the Procurement Officer (AG General), CPO, Quetta Road, Quetta, by hand or write against on the firm's envelope on an working day during office hours, a day before the date opening date. The bid opening time can be extended up to 28-01-2016 on any working day during office hours at the discretion of AG General. Treasury under Head (33-242) (for receipt of bids) in the M/S Sub Office of Pakistan Post, Quetta. Bidding documents from Police or BPPRA website are also required to deposit under the head of Rs.500 and account number held in the office of AG General. (for 28-01-2016).

9. Required samples of each item must be produced at the time of opening of tender. No tender will be accepted without samples.

10. All firms must deposit advance fee of Pak Rupees (Rs. 100,000) which shall be applied to be completed with approved samples for samples.

11. The Department reserves the right to reject any or all bids for any reason.

12. The GP Balochistan shall not be responsible for non-performance of agreement due to change in law, order and policy of the government as notified in Official Gazette from time to time.

13. Firms are responsible for provision of items/goods required to be considered during bid and the quantity shall not make part of the delivery order.

18. Certificates of authorization from manufacturer has to be furnished in case of items.

19. Five Samples (New, Old, Part) of the cost of the bid to be furnished of each item with application. No tender will be accepted without samples.

Note: Other terms and conditions will be implemented as per tender documents, acceptance letter, agreement as well as words written in letter and in spirit.
