Sub: Violation of Balochistan Public Procurement Rules 2014, Project Director, Cadet College Balochistan, Quetta's Request for Proposal Notice for Establishment of Cadet Colleges Killa Abdullah.

Dear Sir,

This is with reference to Cadet College Balochistan, Quetta's Request for Proposal Notice published in daily "Dawn" on 10th September, 2015. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per the advertisement, "only the date & time of submission of tender is mentioned in the advertisement, without stating the date & time of opening of tender that shall also be on the same day". It is violation of Balochistan Public Procurement Rules 2014, Rule No. 33 (1). Stated as under;

33. Opening of Bids. — (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the RFP under the prescribed procedures or issue a corrigendum and extend date accordingly.
