Sub: Violation of Balochistan Public Procurement Rules 2014, Program Director, Balochistan Technical Education & Vocational Training Authority (B-TEVTA), Quetta's Tender Notice for Procurement of Engineering Consultancy Services for Civil Works.

Dear Sir,

This is with reference to B-TEVTA, Quetta's Tender Notice published in daily "The News" on 16th June, 2015. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per the advertisement, it is mentioned tenders may apply within 15 days of publication of the tender, without stating the time and date of opening of tender that shall also be on the same day. It is violation of Balochistan Public Procurement Rules 2014, Rule No. 33 (1). The Rule is quoted below for your reference;

*33. **Opening of Bids.** — (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
