Sub: Violation of Balochistan Public Procurement Rules 2014, Under Secretary (B&A), S&GAD, Civil Secretariat Quetta's Tender Notice for Procurement of Chopper/ Helicopter.

Dear Sir,

This is with reference to S&GAD, Civil Secretariat Quetta's Tender Notice published in daily "Jang" on 14th May, 2015. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per the advertisement, it is mentioned that, "The purchaser reserves the right to reject any offer or all tenders without assigning any reasons". It is violation of Balochistan Public Procurement Rules 2014, Rule No. 40. The Rule is quoted below for your reference;

40. Announcement of evaluation reports.— (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.

Provided that a copy of the evaluation report shall be provided to any bidder who may request for the same.

The above information is forwarded for the purpose of avoiding the mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

TENDER FOR PROCUREMENT OF CHOPPER/HELICOPTER (MI-17 / MI-171E OR EQUIVALENT) FOR GOVERNMENT OF BALUCHISTAN.

1. Government of Balochistan invites tenders through International competitive bidding under Balochistan Public Procurement Rules, 2014 to purchase a Brand New (with latest up gradations) MI-17 / MI-171E or equivalent helicopter for General duties from current production directly from the Original Equipment Manufacturer (OEM). OEM certificate is mandatory and has to be attached with the technical offer. Helicopter should be capable of adoption to different configurations at the shortest possible notice and should be able to safely operate in all weather, terrain and high altitude environments and fit for civil use.
2. The offer must be "SEALED" single package contains two "SEALED" envelopes i.e. one containing the Technical proposal along with qualification documents and the second one containing financial documents.
3. Financial offers must be accompanied with earnest money of 03% (three percent) of the bid amount in the form of pay order / Bank Draft / Bank Guarantee in favor of Secretary to Govt of Balochistan, Services & General Administration Department, Civil Secretariat, Quetta, on local or multinational bank with branches in Pakistan and should be valid upto 120 days i.e. starting from the date of validity of the offer.
4. Financial offers must be quoted in US Dollars / Euros. Letter of Credit will also be opened in US Dollars / Euros.
5. Technical offer must confirm to the given specifications and comply with the requirements of exterior, interior and additional equipments, fittings, spares and tools etc. the offer must include but not limited to a sufficient number of drawings, photographs, catalogues, illustrations and such other information pertinent to the significant characteristics.
6. Sealed envelopes of the Technical proposal / qualification documents will be opened in the presence of bidders who opt to attend on the date of tender opening subsequently, evaluation will be done and opening of the financial proposal of qualified and technically accepted offers shall be done on date / time convenient to those who qualify and the purchaser.
7. The Purchaser reserves the right to accept or reject any offer or to cancel the tendering process and reject all tenders without assigning any reasons, which cannot be challenged in any court of law.
8. The firm may bid directly or through Authorized Sales Representative and attend tender opening. The Authorized Sales Representative must be possession of the authorizing letter from the firm.
9. The helicopter be offered preferably with manufacturers Guarantees / warranties as applicable worldwide and, assurance of comprehensive maintenance / inspections support for the next 10 years for utilization / operation 400 to 600 hours flying per year.
10. The offer preferably must include details of manufacturer's maximum Guarantees / warranties as applicable worldwide of the aircraft including Airframe, Avionics, Engine and Vendor items.
11. The offer must include a specimen of details of contract agreement, which may be scrutinized and considered by the procurement committee for negotiation and finalization. Mode and schedule of payment will be negotiated at the time of signing of the contract.
12. Delivery is to be made immediately at Quetta Pakistan by the Seller at its own risk and cost.
13. No agency commission will be admissible.
14. The conditional offers will not be entertained.
15. Date of delivery should be mentioned clearly.
16. Training for the Flight and Technical Crew will be provided by the supplier/firm.
17. The bidding documents including detailed specifications may be obtained from the office of the Additional Secretary (Admn), Government of Balochistan Services & General Administration Department, Block No.1 Balochistan Civil Secretariat Quetta as well as to be available on www.bppra.org.pk. The tender fee Rs.5,000/- non-refundable should be collected from the bidders on the day of tender opening. The Tenders will be received before or on 06th July, 2015 at 11.00 hours and will be opened at 12.00 hours on the same day in presence of representatives / agents of firms.
