**Sub: Violation of Balochistan Public Procurement Rules 2014, Under Secretary (B&A), Services and General Administration (S&GAD), Quetta's Tender Notice for Purchase of Machinery and Equipment, Furniture & Fixture and Other Miscellaneous Items.**

Dear Sir,

This is with reference to S&GAD, Quetta's Tender Notice published in daily "Dawn" on 12<sup>th</sup> September, 2017. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per advertisement, "The number of above quoted items can be increased/ decreased", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to BPPRA 2014, Rule No. 51 (f) (i), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

***51. Alternate Methods of Procurements.— (1) A Procuring Agency may utilize following alternative methods of procurement of goods, services and works, namely:—***


***(f) Repeat Orders.— means procurement of additional quantities of the item(s) from the original contractor or supplier, where, after the items originally envisaged for the project or scheme have been procured through open competitive bidding, and such additional quantities of the same item(s) of goods or works are needed to meet the requirements of the project or scheme:***

***Provided that—(i) the cost of additional quantities of item(s) shall not exceed fifteen percent (15%) of the original contract amount;***

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Only Manufacturers, Suppliers, Authorized dealers and well reputed firms (active taxpayers) having registration with Federal Board of Revenue (NTN), Balochistan Revenue Authority-BRA, Sales Tax, Income Tax etc are eligible to participate (Necessary docs be enclosed). (ii). The bidder(s) should be eligible to supply goods/services to Government Departments and must have completed at-least 03 similar past assignments (Necessary docs be enclosed). (iii). Bank turnover for the last 03 years / Financial Capacity of PKR 03 Million (Necessary docs be enclosed). (iv). Firm may provide an affidavit duly attested by first class magistrate declaring the firm as "not-black listed" anywhere in Pakistan.

**Method Of Procurement:** Single-stage-Two envelop Bidding Procedure as per Rule 41-(3) of the BPPRA shall be followed for this open competitive bidding. The bids would be evaluated under rule 34 of the B-PPRA Rules, 2014. The lowest bidder fulfilling all the technical and financial requirements would be evaluated accordingly.
