**Sub: Violation of Balochistan Public Procurement Rules 2014, Director, Soil Conservation Forest & Wildlife Department, Quetta's Tender Notice for Construction/ Excavation/ Drilling Works and Provision of Solar System.**

Dear Sir,

This is with reference to Soil Conservation Forest & Wildlife Department, Quetta's Tender Notice published in daily "Dawn" on 15<sup>th</sup> April, 2018. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for submission/ opening of tenders is on 24-04-2018, which is 5 days short. It is violation of BPPRA Rules 2014, Rule No. 16 (1). Stated as under;

*16. Response Time. — (1) The Procuring Agency shall give due consideration to the scope, magnitude and nature of procurement, while deciding the response time which shall not be less than fifteen (15) calendar days from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, as the case may be, in case of National Competitive Bidding, and shall not be less than forty five days (45) from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, in case of International Competitive Bidding.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
