Sub: Violation of Balochistan Public Procurement Rules 2014, Director Inland, Directorate of Inland & Fisheries Balochistan, Dera Murad Jamali's Tender Notice for Establishment of Trout Raceways.

Dear Sir,

This is with reference to Directorate of Inland & Fisheries Balochistan, Dera Murad Jamali's Tender Notice published in daily "Jang" on 15th January, 2016. It is observed that advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per advertisement, the bid security is given as 10%. It is violation of BPPRA Rules 2014, Rule No. 29 (1). Stated as under;

29. Bid Security. - (1) The Procuring Agency may require the bidders to furnish bid security of two per cent in case of procurement of all bids in the form of bank guarantee or Deposit at Call from a scheduled Bank.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
