This is with reference to PHE Division, District Barkhan's Tender Notice published in daily "Express" on 16th January, 2016. It is observed that advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per advertisement, "The undersigned reserved the right to reject all or any bid without assigning any reason under the provision of Baluchistan Public Procurement Rules 2014". It is violation of BPPRA Rules 2014, Rule No. 38(4). Stated as under;

38. Cancellation of Bidding Process.— (4) The Procuring Agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
