**Sub:** Violation of Balochistan Public Procurement Rules 2014, Admin/ Procurement Purchasing Cell, Office of the Project Director (Civil Works), Medical College, Loralai, Quetta's Tender Notice for Supply of Miscellaneous Items.

Dear Sir,

This is with reference to Medical College, Loralai, Quetta's Tender Notice published in daily "Jang" on 18<sup>th</sup> January, 2017. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

In the advertisement, only the last date and time of the opening of tender is mentioned whereas it should also include the date and time of submission of tender that shall be on the same day. Therefore the advertisement is in violation of BPPRA Rules 2014, No. 33 (1). Stated as under:

**33. Opening of Bids.** — (1) *The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

1. Only typed tender on original letter pad, sealed and signed (every page) should be submitted, hand written tenders would not be acceptable. The tenders must be according to College/ hospital specification; alternate rates will not be applicable.
  2. The original brochures must be attached with the bids.
  3. The bidder will furnish address of workshop with a list of workers and land line telephone number mentioned in the tender documents.
  4. The bidder will be bound to ensure the supply within 30 days for local items and 90 days in case of imported equipment's or as early as possible on receipt of order, otherwise the purchase will be made on risk and cost of successful bidder. (From 2<sup>nd</sup> lowest or other genuine bidder).
  5. A pre-bid Meeting will be held on 01/02/2017 at 12:30 PM and Bid Shall be opened by the Procurement Committee on the same at 01:30 PM in the Presence of all participant. The bidders are requested to thoroughly study the standard bidding documents before the Pre-Bid meeting for any clarification of their queries during the said meeting.
  6. The income tax, stamp duty and Professional Tax or any other Government Tax will be charged as per rules. (Only those firms will be honored that are on active Taxpayers list of FBR).
  7. No conditional tender will be acceptable.
  8. The successful bidder will be bound to execute agreement on a stamp paper.
