**Sub: Violation of Balochistan Public Procurement Rules 2014, Executive Engineer-I,
Provincial B&R, District Ziarat's Tender Notice for Construction Work.**

Dear Sir,

This is with reference to Provincial B&R, District Ziarat's Tender Notice published in daily "Jang" on 27th November, 2015. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per the advertisement, "the tender fee is given as PRs 15,000/-", which appears costly in light of the Balochistan Public Procurement Rules 2014, Rule No. 26(2). The Rule is quoted below for your reference;

26. Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
