Please refer to your letter No. 5038/A&P/6/HS/NAB(B)/2017/180, dated 11 May 2017. The Clause 26 (2) clearly specifies the purpose of the Tender Fee, which is preparation and printing of bidding documents, and which shall not exceed the cost of preparation and printing of the documents. The Tender fee of Rs. 13,000/- was based on the Notification No. DS-GEN/ 2/ 2009/ 5645-60, dated 14.12.2009 (Copy enclosed). The notification clearly specifies the Tender fee of Rs. 13,000/- for C-1 Contractors.

It is relevant to mention here that that the fee of Rs. 13,000/- is much less had the actual cost of professional and direct computer printing charges been considered.

However, by mistake the Invitation to Bids also mentioned an amount of Rs. 12,000/- as bid fee.

In response to the advertisement only one contractor/ supplier, M/S Alpha Pipe Industries (Pvt.) Ltd purchased the bidding documents on the submission of Rs. 13,000/- in the form of green Challan duly deposited in the National Bank of Pakistan City Branch Quetta (Copy attached). No other fee was charged to them.

However, in future this office would ensure that such error/ oversight is avoided.

- Eligibility:-**
- Be registered with Pakistan Engineering Council (PEC) in the appropriate category and valid renewal up to date.
  - Should be ISO 9000 certified duly accredited with Pakistan National Accreditation Council (PNAC).
  - Have valid registration with (PSQCA) Pakistan Standards and Quality Control Authority.
  - Have registration with FBR and Sales Tax Department and enlisted in the duly active tax list (ATL) on FBR website.
  - Document evidence of at-least one similar nature of Supply / Installation of pipeline projects with satisfactory certificate issued by the employer. The JV/ Firm should have a minimum annual turnover of Rs. 400 million. Should submit audited financial statements of the last 3 years.
  - The bidder shall be a Manufacturer.
  - All rights for acceptance or rejection of tenders reserved. Under BPPRA Rules.
