Sub: Violation of Baluchistan Public Procurement Rules 2014, Director (Planning & Development), Lasbela University of Agriculture, Water and Marine Sciences, District Gwadar's Pre-qualification Notice for Civil Works.

Dear Sir,

This is with reference to LUAWMS, Uthal's Pre-qualification Notice published in daily "Jang" on 17th April, 2018. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, the Pre-qualification document fee is charged as PRs 10,000/-, which appears costly in light of the BPPRA Rules 2014, Rule No. 19(1) (b). Stated as under;

19. Process of Pre-qualification – (1)(b) Procuring Agency shall provide a set of pre-qualification documents containing scope of contract, a clear set of requirements for qualification and evaluation criteria to any supplier or contractor, subject to payment of price, if any, which shall not exceed the limit, as prescribed in these Rules, and shall indicate the time and place where the documents can be obtained. Alternatively, if the Procuring Agency does not wish to issue pre-qualification documents, it shall include the scope of work and a clear set of requirements for pre-qualification and the evaluation criteria in the notice for pre-qualification;

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the Pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

6. Incomplete/ Conditional or Application received after due date and time shall not be considered for prequalification of contractors.
