As per advertisement, "Sangar Housing Project, Gwadar reserves the right to reject any or all bids without assigning any reason." It is violation of BPPRA Rules 2014, Rule No. 40. Stated as under;

*40. Announcement of evaluation reports.— (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
