Dear Sir,

This is with reference to Provincial B&R, Dera Bugti's Tender Notice published in daily "Express" on 17<sup>th</sup> January, 2016. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per the advertisement, the tender fee is given as PRs 15,000/-, which appears costly in light of the Balochistan Public Procurement Rules 2014, Rule No. 26(2). The Rule is quoted below for your reference;

*26. Provision of Bidding Documents.— (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
