Sub: Violation of Balochistan Public Procurement Rules 2014, Chairman, Balochistan Development Authority, Quetta Cantt's Tender Notice for Construction, Rehabilitation and Restoration Works.

Dear Sir,

This is with reference to Balochistan Development Authority, Quetta Cantt's Tender Notice published in daily "Dawn" on 20th January, 2016. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, the last date for the submission of tenders is given as 8-02-16, whereas the opening for Schemes at serial no. 5 to 11 is given on 11-02-16. It is violation of Balochistan Public Procurement Rules 2014, Rule No. 33 (1). Stated as under;

33. Opening of Bids. — (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
