Subject: COMPLIANCE OF BALOCHISTAN PUBLIC PROCUREMENT RULE 2014 Rule no. 15 (1) (2), 27 (4)

The undersigned is directed to refer to the subject cited above that it has been observed that several tenders uploaded on B-PPRA website by various Procuring Agencies are with-out Bidding document & NIT attachments which shows **ERROR 404** while clicking on public end. It is to say that this is the core responsibility of Procuring Agency to ensure the availability of NIT and Bidding document of all active tenders on B-PPRA website as per B-PP Rule-2014.

The problems could be the reason of non-availability of tender documents or Error 404.as follows:

- i. Slow internet Speed
- ii. Document Over Size
- iii. Lack of computer literacy/understanding.
- iv. Early Submission/adding of tender before proper attachment of documents
- v. None verification of tender at public end by procurement Agency after uploading tenders.


All concerned procuring agencies are here advised to ensure full-fill need of requirements of the Balochistan Public Procurement Rule – 2014, particularly the publication of tender on B-PPRA website, a mandatory requirement as per Rule no. 15 (1) (2), 27 (4).

Moreover, B-PPRA MIS/IT wing is always available for support/training and assistance. The contact details of the IT support team are also shared and available on BPPRA website contact details link. <http://bppra.gov.pk/contacts.php>.

Being aware of the technical issues with existing website this authority is in process of developing a new state-of-the-art 'ERP system' and more user-friendly website to facilitate all users/procuring agencies/suppliers citizens /officials and to ensure transparency. This newly designed website called tender will be open on 12th Jan 2016.

It is further to say that we are striving hard to maintain a sound system and to facilitate procuring agencies in every respect of procurement process.
