This is with reference to S&GAD, Quetta's Tender Notice published in daily "Dawn" on 21st July, 2016. It is observed that advertisement is in violation of the Balochistan Public Procurement Rules 2014.


As per advertisement, the bidding document fee is given as PRs 50,000/- (non-refundable), which appears costly in light of the BPPRA Rules 2014, Rule No. 26(2). Stated as under;

26. Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
