Sub: Violation of Balochistan Public Procurement Rules 2014, Chairman, Municipal Committee, Ziarat, Balochistan's Tender Notice for Purchasing of Excavator.

Dear Sir,

This is with reference to Municipal Committee, Ziarat's Tender Notice published in daily "Dawn" on 16th May, 2015. It is observed that the advertisement is in violation of the BPPRA 2014.

As per the advertisement, no information regarding issuance of tender documents is given for bidders, it is only mentioned to call for any further query, which is violation of Balochistan Public Procurement Rules 2014, Rule No. 15(4) & 26 (1). Stated as under;

15. Methods of Notification and Advertisement (4) *The notice inviting tender shall at minimum contain the following information:-*

(a) Name, postal address, telephone number(s), fax number, e-mail address (if available) of the Procuring Agency;

(b) Purpose and scope of the project;

(c) Broad qualification and eligibility criteria;

(d) schedule of availability of bidding documents, submission and opening of bids, mentioning place from where bidding documents would be issued, submitted and would be opened;

(e) Amount and manner of payment of tender fee and bid security; and

(f) Any other information that the Procuring Agency may deem appropriate to disseminate at this stage.

26. Provision of Bidding Documents. — *(1) The Procuring Agency shall provide the bidding documents to all interested bidders in accordance with the procedures and requirements specified in the Notice Inviting Tender.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
