Subject: Irrelevant/Unfair recruitment against the post “Health education and Nutrition Officer, PPS 07” equal to BPS 17 in Nutrition Programme, Health Department Gilgit Baltistan.

Respected Sir,

It states that a test was conducted by Career Testing Service Pakistan for the post of “Health Education and Nutrition Officer PPS 07” equal to BPS 17 in Nutrition Programme Health Department Gilgit Baltistan dated **22-03-2019**. One hundred and fifteen (115) candidates were selected after test for interview. Sir as according to the title of the posts the candidates from nutrition degrees should allow to appear for the test but CTSP allowed all candidates of any degree for the said post. Sir we are candidates having **BS and MS degrees in Human Nutrition and Dietetics** where should we go? The department interviewed the selected candidates after test from **19-22 August 2019** after that the result has been announced dated **16-Sep-2019** and the department rejected us and recruited candidates of their own choice. Even it was mentioned on the advertisement that the priority will be given to candidate’s tehsil wise but they have given priority to other candidates in our tehsil (**Gamba, Skardu**). Respected sir this is totally unfair because we have degrees in **MS/M-Phil in Human Nutrition** what is our career now? Where should we go? If our own posts and vacancies related to our degree are giving to others. Why we the Nutritionist and Dieticians are not eligible for other health posts if others are eligible for our posts? Respected sir even round about all the candidates selected for the said post are those candidates who have not related degrees according to the said post. Respected sir you have always mentioned this issue about scaling up nutrition of the Pakistan in your speeches, if the country neglects the professionals and hires non-professionals, then I am sorry to say this is totally corruption. This government should take action against this unfair and engorging recruitment. Evidences and references are enclosed with this application.

Demands:

- Correct the eligibility criteria for the said post.
- Reschedule the interview.
- Give priority to candidate tehsil wise.
- Selected candidates should have degree related to the Food, Nutrition and Dietetics.
