Dear Sir,

This is with reference to Irrigation Division, Khuzdar's Tender Notice published in daily "Dawn" on 22<sup>nd</sup> February, 2017. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.


As per advertisement, the Tender fee for work under Sr. No 1 is given as PRs 13,000/-, which appears costly in light of the BPPRA Rules 2014, Rule No. 26(2). Stated as under;

***26. Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.***

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
