Sub: Violation of Balochistan Public Procurement Rules 2014, Treasurer, University of Balochistan, Quetta's Tender Notice for Printing of Prospectus.

Dear Sir,

This is with reference to University of Balochistan, Quetta's Tender Notice published in daily "Dawn" on 22nd January, 2016. It is observed that the advertisement is in violation of the BPPRA Rules 2014.


There is an ambiguity in the advertisement, as point No.7 states that the last date for the deadline of tender is 23-01-16, whereas the opening is kept on 08-02-16 while in the table the submission and the opening date is stated as 08-02-16. It is violation of Balochistan Public Procurement Rules 2014, Rule No. 33 (1). Stated as under;

33. Opening of Bids. — (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
