Subject: **Response against letter mentioning Violation of Baluchistan
Public Procurement Rules 2014**

Dear Sir,

This letter is in response to your letter No TL16/1901/15A mentioning violation of Baluchistan public procurement rules 2014 by Quetta institute on Medical Sciences against tender notice published in daily "Express" on 16th January 2015.

It is to inform you that we reviewed the violation thoroughly in light of Baluchistan PPRA rule 2014. The tender notice published in daily "Express" on 16th January 2015 was as per BPPRA Rule No. 17 (a) & (b). The tender published was as per said rule.

17. Exceptions.— No deviation from the requirements under Rules 15 and 16 is permissible in any circumstances, however in the following cases it may be excepted for reasons to be recorded in writing:—
(a) in cases of emergency, minimum time periods, specified in rule 16 may be reduced subject to the prior approval with reasons to be recorded by the Head of Department
(b) in cases of procurement related to national security, the requirement of advertisements and publication under rule 15 may be waived, provided the Head of Department declares beforehand that such a publication could jeopardize national security objectives;

The date mentioned in tender is amended according to BBPRA Rule No. 33 (1) for corrigendum, Dated 26th January 2016.

Moreover, the boundary wall and fence of boys hostel needs immediate work as currently it is supported by wooden planks but more importantly due to current security concerns we decided to carry out procurement on immediate basis.
