This is with reference to Provincial TB Control Program Balochistan, Quetta's Tender Notice published in daily "Jang" on 24<sup>th</sup> January, 2018. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.


In the advertisement, the tender submission date is given as 13-2-2018 while the tender opening date is on 12-02-2018. Therefore the advertisement is in violation of BPPRA Rules 2014, No. 33 (1). Stated as under;

*33. Opening of Bids. — (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

**Eligibility of Bidders for Anti TB Medicine:** (a) The bidder must have successfully completed similar nature of assignments of total supply worth Pkr: 25 million. (b) Turnover of at least Pkr: 25 million in last three years showing financial capacity of the firm. (c) Registration with relevant taxation departments. (d) Registration with the Drug Regulatory Authority of Pakistan.

**Eligibility of Bidders for Other Items:** (a) The bidder must have completed 5 assignments of similar nature of work in last 5 years. (b) Turnover of at least Pkr: 10 million in last three years showing financial capacity of the firm for Lab Reagents/Equipment's. (c) Turnover of at least Pkr: 2 million (for each category) in last three years showing financial capacity of the firm i.e. Digital Weighting Scale, Recording Reporting tools & Sign Boards/Standees. (d) Registration with relevant taxation departments. (e) Bidder must have functional office in Quetta, Balochistan
