Sub: Violation of Balochistan Public Procurement Rules 2014, Project Director, Dera Bugti Development Package, Dera Bugti's Tender Notice for Improvement & Black Topping of Roads.

Dear Sir,

This is with reference to Dera Bugti Development Package, District Dera Bugti's Tender Notice published in daily "Dawn" on 23rd March, 2016. It is observed that advertisement is in violation of the Balochistan Public Procurement Rules 2014.

1. As per advertisement, the Tender form fee is given as PRs 15,000/- for S.No.1 and PRs 20,000/- for S.No.2, which appears costly in light of the BPPRA Rules 2014, Rule No. 26(2). Stated as under;

26. Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.

2. Also, "The undersigned reserves the right to reject all or any bids without assigning any reason therefore under the provision of Balochistan Public Procurement Rules, 2014". It is violation of BPPRA Rules 2014, Rule No. 38(4). Stated as under;

38. Cancellation of Bidding Process.— (4) The Procuring Agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
