Sub: Violation of Balochistan Public Procurement Rules 2014, Executive Engineer-I, Provincial B&R, District Dera Bugti's Tender Notice for R&M of A-I Roads.

Dear Sir,

This is with reference to Provincial B&R, District Dera Bugti's Tender Notice published in daily "Jang" on 21<sup>st</sup> November, 2015. It is observed that advertisement is in violation of the BPPRA Rules 2014.

1. As per advertisement, "15 days of response time is not given and the last date of submission of tender is given on 03-12-2015, which is 2 days short". It is violation of BPPRA Rules 2014, Rule No. 16 (2). Stated as under;

*16. Response Time. — (1) The Procuring Agency shall give due consideration to the scope, magnitude and nature of procurement, while deciding the response time which shall not be less than fifteen (15) calendar days from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, as the case may be, in case of National Competitive Bidding, and shall not be less than forty five days (45) from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, in case of International Competitive Bidding.*


2. Also that, "The undersigned reserves the right to reject any or all bids without assigning any reason therefore under the provision of BPPRA Rules, 2014". It is violation of BPPRA Rules 2014, Rule No. 38(4). Stated as under;

*38. Cancellation of Bidding Process.— (4) The Procuring Agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds..*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
