This is with reference to District Council, Kharan's Tender Notice published in daily "Jang" on 22<sup>nd</sup> December, 2017. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.


As per advertisement, "The tendering authority will reserve the right to accept /reject any one or all tender rates without providing any reason." It is violation of BPPRA Rules 2014, Rule No. 40. Stated as under;

*40. Announcement of evaluation reports.— (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tenders under the prescribed procedures or issue a corrigendum and extend date accordingly.
