Dear Sir,

This is with reference to Cadet Colleges Balochistan, Quetta Cantt's Tender Notice published in daily "Jang" on 25<sup>th</sup> July, 2018. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, the tender fee under is charged as PRs 10,000/-, which appears costly in light of the BPPRA Rules 2014, Rule No. 26(2). Stated as under;

***26. Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.***

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
