**Sub: Violation of Baluchistan Public Procurement Rules 2014, Principal, Mekran Medical College, Turbat's Tender Notices for Supply of Medical Books and Supply and Installation of Furniture and Fixture.**

Dear Sir,

This is with reference to Mekran Medical College, Turbat's Tender Notices published in daily "Dawn" on 24<sup>th</sup> March, 2017. It is observed that the advertisements are in violation of the Balochistan Public Procurement Rules 2014.

As per advertisement, "The Procurement Committee/Principal has the rights to accept or reject any or all bids without assigning any reason." It is violation of BPPRA Rules 2014, Rule No. 40. Stated as under;

*40. Announcement of evaluation reports.— (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tenders under the prescribed procedures or issue a corrigendum and extend date accordingly.
