It is violation of Balochistan Public Procurement Rules 2014, Rule No. 19. The Rule is quoted below for your reference;

19. Process of Pre-qualification.—(1)(f) procuring agency shall, on written request of the applicant(s) communicate to the applicant(s) the reasons for not pre-qualifying them, though it shall not be obliged to justify these reasons;

The above information is forwarded for the purpose of avoiding the mis-procurement charge and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.
