Sub: Violation of Balochistan Public Procurement Rules 2014, Assistant Director, Local Government, District Jaffarabad's Tender Notice for Construction Works.

Dear Sir,

This is with reference to Assistant Director, Local Government, District Jaffarabad's Tender Notice published in daily "Jang" on 21st October, 2015. It is observed that advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per advertisement, it is mentioned that, "The undersigned reserves the right to reject any or all bids without assigning any reason therefore under the provision of Balochistan Public Procurement Rules 2014". It is violation of BPPRA Rules 2014, Rule No. 40. Stated as under;

40. Announcement of evaluation reports.— (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.

Provided that a copy of the evaluation report shall be provided to any bidder who may request for the same.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
