Dear Sir,

This is with reference to Sardar Bahadur Khan Women's University, Quetta's Tender Notice published in daily "Jang" on 26th October, 2017. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

In the advertisement, the tender submission date is given as 9-11-2017 while the tender opening date is on 10-11-2017. Therefore the advertisement is in violation of BPPRA Rules 2014, No. 33 (1). Stated as under;

33. Opening of Bids. — (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
