Sub: Violation of Balochistan Public Procurement Rules 2014, Registrar, Balochistan High Court, Quetta's Tender Notice for Purchase of Ten Cars.

Dear Sir,

This is with reference to Balochistan High Court, Quetta's Tender Notice published in daily "Dawn" on 19<sup>th</sup> December, 2015. It is observed that advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per advertisement, it is mentioned that, "The undersigned has the right to reject or accept any or all tenders without assigning any reason". It is violation of BPPRA Rules 2014, Rule No. 40. Stated as under;

*40. Announcement of evaluation reports. — (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.*

*Provided that a copy of the evaluation report shall be provided to any bidder who may request for the same.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
