
As per advertisement, the Tender form fee is given as PRs 10,000/-, which appears costly in light of the BPPRA Rules 2014, Rule No. 26(2). Stated as under;

26. Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
