**Sub: Violation of Balochistan Public Procurement Rules 2014, Executive Engineer-I,
Provincial B&R, District Harnai's Tender Notice for Construction of B/T Roads.**

Dear Sir,

This is with reference to Provincial B&R, District Harnai's Tender Notice published in daily "Dawn" on 22nd October, 2015. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, "the last date for submission of tender documents is given as 03-11-15 whereas the opening of tender documents is kept on the next day, that is, 04-11-15". It is violation of Balochistan Public Procurement Rules 2014, Rule No. 33 (1). Stated as under;

*33. **Opening of Bids.** — (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
