This is with reference to Provincial B&R, District Dera Bugti's Tender Notice published in daily "Dawn" on 21st December, 2015. It is observed that advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, it is mentioned that, "The undersigned reserves the right to reject all or any bids without assigning any reason therefore under the provision of Balochistan Public Procurement Rules, 2014". It is violation of BPPRA Rules 2014, Rule No. 38(4). Stated as under;

38. Cancellation of Bidding Process. — (4) *The Procuring Agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
