This is with reference to Provincial B&R, District Kalat's Tender Notice published in daily "Dawn" on 23<sup>rd</sup> September, 2015. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per the advertisement, "the Tender form fee is given as PRs 20,000/-", which appears costly in light of the Balochistan Public Procurement Rules 2014, Rule No. 26(2). The Rule is quoted below for your reference;

**26.** Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
