Sub: Violation of Balochistan Public Procurement Rules 2014, Executive Engineer-II, Provincial B&R, Uthal, District Lasbela's Tender Notice for Construction of Additional Components.

Dear Sir,

This is with reference to Provincial B&R, Uthal, District Lasbela's Tender Notice published in daily "Dawn" on 29th January, 2016. It is observed that advertisement is in violation of the BPPRA Rules 2014.

1. As per advertisement, the Tender form fee is given as PRs 15,000/-, which appears costly in light of the BPPRA Rules 2014, Rule No. 26(2). Stated as under;

26. Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.

2. Also, "The undersigned reserves the right to reject all or any bids without assigning any reasons therefore under the provision of Balochistan Public Procurement Rules, 2014". It is violation of BPPRA Rules 2014, Rule No. 38(4). Stated as under;

38. Cancellation of Bidding Process.— (4) The Procuring Agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
